- 3. The research proposal shall be within the areas of research focus of IRTI
- 4. The fellow's research shall be directed towards leading the development and sustenance of the Islamic financial industry by supporting socio-economic development in member countries of the IsDB
- 5. The fellow's research shall aim to support the realization of the IsDB vision, where IRTI has to play a key role in becoming a world class knowledge-based organization.
